These photos are of real volunteers in action and are provided free-of-charge to nonprofit organizations to assist with their promotion of volunteering.

These images can not be used for reproduction until you obtain Volunteer Alberta's permission and login information and are subject to terms and conditions.

The login is provided for one single nonprofit organization.
The login becomes invalid 6 months after it is issued.

To obtain a login, Volunteer Alberta must be satisfied that the images will be used in the context of promoting volunteering. To request a login, please email your intentions for use of the photos and your contact information to volab@volunteeraberta.ab.ca.

By use of the login, you and your organization have agreed to the following terms and conditions:

Terms and Conditions For Use of Pictures

- 1.0 *Definition:* Reproduction means any form of copying or publication of the whole or any part of any picture whether by printing, photographing, slide projection (whether or not to an audience), photocopying, artist's reference, artist's illustration, layout or presentation, electronic, digital or mechanical means or by any other means, and reproduce shall be construed accordingly.
- 2.0 *Definition:* Client means your organization's employees and/or volunteers. Participating organizations must be nonprofit.
- 3.0 Volunteer Alberta reserves the right not to issue a login if it cannot be satisfied that the pictures will be used for the context of promoting volunteering.
- 4.0 No ownership or copyright in any picture shall pass to the Client upon issuance of the login in respect of the picture.
- 5.0 **The client shall ensure that that the pictures are used in the context of promoting volunteering only.**
- 6.0 Please inform Volunteer Alberta immediately in writing of any known misuse of the any picture while in the Client's possession or that of any third party.
- 7.0 The Client may make minor retouches, alterations, enhancements or additions to or deletions from any picture (such as altering contrast, colour, or density; retouching; addition of minor components; increasing or diminishing the importance or impact of individual features; removal of distracting and/or irrelevant details; softening; simplifying and extending background), but may not otherwise retouch, alter, manipulate, add to, delete from or enhance any picture by electronic or other means, or Reproduce any

- picture which has been so retouched, altered, manipulated, added to, deleted from or enhanced.
- 8.0 Any reproduction rights are granted by way of license only and no partial or other assignment of copyright should be implied. Reproduction rights granted may not be assigned or sub-licensed.
- 9.0 **No picture may be used in a manner which can be reasonably construed as derogatory, libelous, defamatory or slanderous of any person depicted in it.**
- 10.0 **The Client shall ensure that all pictures are reproduced with the credit line supplied in relation to the pictures.** In the lower corner of the picture the © **Volunteer Alberta 2005** credit line must appear.
- 11.0 No warranty is given by Volunteer Alberta as to the existence or validity of model or other releases in respect of any picture. Volunteer Alberta shall not be liable for the absence of such a release or for any defect in any existing release.
- 12.0 Volunteer Alberta gives no warranty as to the accuracy of any description of pictures and the identification of persons appearing in them and shall not be liable to the Client for any inaccuracies.
- 13.0 Volunteer Alberta shall not be liable for any loss or damage suffered by the Client or by any third party arising from any defect in any picture or its caption or in any way from its reproduction.
- 14.0 Volunteer Alberta shall not be liable for any damage or loss caused by viruses transmitted through the Photo Gallery.
- 15.0 Volunteer Alberta is not liable for any indirect consequential losses or expenses suffered by the Client, howsoever caused, and including, without limitation, loss of anticipated profits, goodwill, reputation, business receipts or contracts, or losses or expenses resulting from third party claims.
- 16.0 The failure to exercise or delay in exercising a right or remedy provided by these Terms or by law does not constitute a waiver of the right or remedy or a waiver of other rights and remedies.
